The award of the contract will be to the bidder whose quotation has been determined to be substantially responsive and who has offered the lowest evaluated quotation price.

- 5.1 Notwithstanding the above, the Purchaser reserves the right to accept or reject any quotations and to cancel the bidding process and reject all quotations at any time prior to the award of contract.
- 5.2 The bidders whose bid is accepted will be notified of the award of contract by the Purchaser. The terms of the accepted offer shall be incorporated in the purchase order.
- 5.3 **Part payment would be made during current financial year and balance in the next financial year.**
